Dear Vendor:

The Carthage Area Chamber of Commerce is hosting its Annual Fireworks Festival on Saturday, July 13, 2019 from 4:00 p.m. until dusk. We would like to invite you to set up as a vendor that day beginning any time in the afternoon, and until at least 8:00 p.m., or as much later as you wish. The fireworks are scheduled to be starting around dusk, which is about 9:30 p.m.

The fireworks festival generally brings in over 2,000 people from all around the area. We have been told that our fireworks are the best around! So we have something to brag about!

This year's festival has expanded a bit. We expect to have many family-oriented activities, which include, but are not limited to: Live music by "Patti Stanford Band", bouncy house for the children, magician & balloon artist, professional face painting, the NYS Zoo, race car displays, craft vendors, food vendors and other merchandise vendors, displays, and more. We hope that this will be a day filled with excitement! More details are still in the planning stages.

Enclosed is a Vendor Registration Form. All vendors must have a valid NYS sales tax ID number unless you are a non-profit organization, and all necessary health permits, if needed. **Due to several complaints: Smoke Bombs, sparklers, and poppers are not allowed to be sold or used at this event. Vendors caught selling any of these items will be asked to leave the event with no refund.**

The Village of Carthage requires all vendors to have a Peddlers Permit. The cost is \$10.00 per event, or \$50.00 for one year. The form for this is enclosed, and you must have this in place at least one week prior to the event. THE PROCESSING OF THIS APPLICATION IS DONE DIRECTLY THROUGH THE VILLAGE OF CARTHAGE AND ALL FEES SHOULD BE PAYABLE BY CHECK TO THE VILLAGE OF CARTHAGE FOR THIS PERMIT. A VALID PHOTO ID MUST BE SENT WITH THE PERMIT APPLICATION. PLEASE DO NOT RETURN THE PERMIT APPLICATION AND FEE TO THE CHAMBER – IT NEEDS TO GO DIRECTLY TO THE VILLAGE OFFICE AT 120 S. MECHANIC ST., CARTHAGE, NY 13619.

If you are interested in joining us that day, please fill out and return the registration forms with the appropriate fee as soon as possible. The event will go on **RAIN OR SHINE**, and you will be responsible for your own protection from the weather and elements. Electricity is extremely limited, so we cannot guarantee that this will be available to you.
